ORDINANCE 1-2020 AUTHORIZING THE CLERK-TREASURER OF THE VILLAGE OF NAVARRE, OHIO TO TRANSFER FUNDS WITHIN THE VARIOUS AUTHORIZED CATEGORIES OF ALLOCATIONS ENUMERATED HEREIN, AND DECLARING SAME TO BE AN EMERGENCY

WHEREAS, it is in the best interest of the health, safety and welfare of the residents of the Village of Navarre, Ohio that the Clerk-Treasurer of said Village be authorized to transfer funds within the several enumerated categories, as described herein; and




