RESOLUTION NO. 2018 - 17

A RESOLUTION SPECIFYING DATE OF ELECTION TO LEVY  
ONE-QUARTER PERCENT (0.25 %) INCOME AND NET PROFITS  
TAX WITHIN VILLAGE CORPORATE BOUNDARY

Whereas, the Village of Navarre has passed Ordinance 22-2018, seeking an additional one-quarter percent (0.25 %) tax to be imposed upon municipal taxable income earned within the corporate boundary of the Village, and

Whereas, said one-quarter percent (0.25 %) tax is in addition to a one-and-half percent (1.5 %) tax currently in place, thus requiring the issue to be submitted to the electors of the Village of Navarre,

Now Therefore, Village Council Resolves as follows —

That the issue of an additional one-quarter percent (0.25 %) tax upon municipal taxable income earned within the corporate boundary of the Village be referred to Stark County Board of Elections, to be placed on the ballot in the primary election conducted May 7, 2019, and

That the ballot be substantially in the following form:

*"Shall the Ordinance providing for an additional one-quarter percent (0.25 %) tax on municipal taxable income earned with the corporate boundary of the Village, for the sole purpose of reconstruction, resurfacing, and repair of Village streets, alleys, and curbs and gutters, be passed?"*

*For the Income Tax*

*Against the Income Tax"*

The Clerk-Treasurer shall file with the Board of Elections a certified copy of this resolution, together with a certified copy of Ordinance 22-2018.
