RESOLUTION NO. 2018-4

A RESOLUTION AUTHORIZING VILLAGE ADMINISTRATOR TO
REJECT ALL BIDS FOR TRASH AGGREGATION AND
TO SEEK NEW BIDS FOR EXCLUSIVE RESIDENTIAL
SERVICE WITHIN THE VILLAGE

Whereas, the Village of Navarre advertised for bids for collection within the Village of garbage, rubbish, and recyclables, said bids being due May 25, 2018, and

Whereas, only Kimble Companies submitted bids, one of which was an alternate for Kimble to serve as the exclusive hauler of residential garbage and rubbish within the Village, for the sum of \$11.08 per month per customer, with 95 gallon cart included, and

Whereas, the Village of Navarre did not seek bids for exclusive residential service, but now believes such would for the substantial economic benefit of the residents of the Village of Navarre, and


Whereas, the Village of Navarre has the authority to enter into a contract for exclusive residential service, pursuant to Ohio Supreme Court precedent, and

Whereas, while the Village of Navarre possesses the authority to enter into a contract with Kimble Companies on its alternate bid to serve as the exclusive hauler of residential garbage and rubbish within the Village, Village Council desires to give all potential bidders an opportunity to bid for service for which bids were not previously sought,

Now Therefore, Village Council Resolves as follows –

That the Village Administrator is authorized to reject all bids, and to re-advertise for bids, to include exclusive residential service, and further to include an option for direct billing by the successful bidder to the residential customers; so long as the new bid specifications are substantially similar to the prior bid specification other than to reflect this Resolution, and so long as the new bid specifications are acceptable to the Village Solicitor, the Village Administrator shall not be required to return to Village Council for approval of the new bid package.
