RESOLUTION NO. 2018-6

A RESOLUTION AUTHORIZING BEGINNING OF CONSTRUCTION
OF RESCUE VEHICLE STATION / OFFICE STRUCTURE ON
UNIMPROVED ALLEY BETWEEN PARCELS 10010162 AND
1280028, BY NAVARRE-BETHLEHEM JOINT FIRE DISTRICT,
IN ANTICIPATION OF APPLICATION FOR ALLEY VACATION

Whereas, the Navarre-Bethlehem Joint Fire District ("Fire District") is a creation of the Village of Navarre and Bethlehem Township, and in the process of acquiring certain real estate at the intersections of Ohio and South Main, including Stark County tax parcel 1280028, and

Whereas, the Fire District already owns Stark County tax parcel 10010162, which lies across a ten foot platted but unimproved alley, and

Whereas, the Fire District intends to submit an application for vacation of said platted but unimproved alley between said parcels 1280028 and 10010162, and

Whereas, the Fire District intends to construct a new rescue vehicle station and office on said parcels 1280028 and 10010162, part of which station will lie on said platted but unimproved alley, and

Whereas, said platted but unimproved alley is not and never has been used for vehicle traffic, and

Whereas, time is of the essence for the Fire District in being able to commence construction at the earliest time possible, which may well occur before the platted but unimproved alley can be vacated, and

Whereas Council deems construction of the new rescue vehicle station and office to be for the best interest of the health and safety of the Navarre community, both residents and those traveling into and through the Village,

Now Therefore, Village Council Resolves as follows –

That Navarre-Bethlehem Joint Fire District is granted authority to commence construction of a rescue vehicle station and office upon the above described platted but unimproved alley as soon as the Fire District deems such construction necessary.
